- 3. The candidates should produce the following at the time of Interview without fail.

 Transfer certificate and conduct certificate in original and one attested copy from the
- i) Head of the institution where she studied last
 - ii) Community certificate in the prescribed format in original along with two attested copies.
 - iii) Original statement of marks obtained at the Bachelor's Degree Examination original and two attested copies ONLY IN THE CASE OF CANDIDATES APPLYING FOR MASTER'S DEGREE .
 - iv)Income certificate if available in the case of candidates belonging to SC & ST

- v) Pass certificate in the case of candidates from universities other than Madras University.
 - (All the original certificates except the Community Certificate and mark sheet will be retained by the college. The candidates are therefore advised to take enough Photo copies of the certificates before submitting to the college)
 - 4. Admission is subject to verification of marks certificate by Director of Government Examination and if the mark certificate is found to be bogus, admission is liable for cancellation besides and criminal action will be taken.
 - 5. The candidates who possess qualification which is required to be recognised by the University of Madras must get it recognised and produce the same along with their application or at least at the time of interview.
